Weed Treatment: We are in year 3 of a 5 year agreement. Nancy Whitney contacted Prairieville Township regarding the extension of the weed treatment. Talked to Ted DeVries 12/29/15.

We have 2 options:

- 1. Ask the Prairieville Township board to create a Special Assessment District. If there is opposition to the weed assessment signatures totaling 20% of land mass would defeat.
- 2. Gather signatures from 80% of land mass and weed control could be extended.

Any signatures gathered will only be good for 12 months. Additional research into this will be required. Nancy Whitney will meet with Greg and Kathy Yarworth, as they were deeply involved in the original weed control issue.

Old Business:
