Secretary's Report: none

Treasurer's Report:

- We have a total of \$41,237.87 in our accounts
- General Fund has \$16,728.77 (We've paid for street signs but will probably have more costs for hardware.)
- Fireworks Fund has \$20,222.82 (We've paid \$7,500 for 2020 fireworks. Still owe \$7,500. We moved \$2,500 from general fund to the fireworks fund to cover the shortage for this year. So far we have collected about \$12,900 of the \$15,000 needed for next year's fireworks so we are about \$2,000 short. We will probably get a few more straggling donations, but probably not anywhere near \$2,000.
- Buoy Fund has \$4,286.28 and the cost of the newly purchased buoys has already been deducted from that account.
- Current membership count is 274.
- Mike Whitney, Eric Hibma, and Andrea Bernard agreed to be listed as Directors on the Nonprofit Corporation Annual Report that is due October 1

Andrea Bernard will send Randy Klinger some of her other ideas to increase membership.
